

- 9. To co-operate with the existing academics societies and institutes having similar objectives for the furtherance of Analytical sciences and their applications and with such other associations when found.
- 10. To affiliate itself with suitable international organizations for the promotion of common objectives and to provide adequate representations of this country in international forums.
- 11.To frame, construct, adopt, prepare, regulate or sanction rules, regulations, laws and bye-laws whereby the society may think fit to guide itself or whereto the society should conform or have resources to carry out its objectives or otherwise, and from time-to-time vary, alter or confirm one or other of such rules, regulations, laws and bye-laws
- 12. To undertake and execute all other acts which shall promote the aims and objectives of the society.

The outcome of the meeting is given below:

1. The meeting started with the felicitation of newly elected Chairman by the outgoing Executive Chairman and the outgoing Chairman, followed by introduction of the members present. After this, formal handling -taking over

ritual was done where Dr Christopher congratulated and handed over the baton to Mr. Alok Sharma as the new Chairman.

Chairman, while welcoming all the members for the meeting thanked all the EC members and emphasized on to work together for betterment of ISAS-DC society so that it will reach at new heights in near future. Chairman suggested to start a news bulletin, quarterly or yearly basis and preparing a compendium of test facilities related to emerging and sunrise areas like green hydrogen, biofuels etc available with various organizations, institutes and industries. He also suggested to approach few industries to become corporate members of society.

2. Dr Dheer Singh, Secretary, presented a brief history of ISAS and Delhi Chapter followed by briefing the members about various activities held during the last year and also presented the audit financial statement of the Chapter, which was accepted by the voice vote.

It was informed that total membership stands at 1598 till 2023 & 25 new life members were made in 2023-24. Secretary also apprised the members about various schemes like Financial Assistance Scheme for Students/Research Scholars for participation in Conference abroad, Lifetime Achievement Award, Merit-cum-Means Scholarship Scheme for Poor Students and Research Excellence Award / Young Scientist Award.

3. Chairman advised to give ample publicity to the financial assistant schemes for young researchers to attend international conferences abroad and also propagate financial schemes for poor /needy students.

For the lifetime Achievement / young scientist awards, it was decided to change the age brackets as the following:

Life-time Achievement Award: Age > 55 years

Young Scientist Award: Age < 55 years

It was also decided to initiate the process for inviting applications for these awards for the year 2024-25 and present the awards in the forthcoming GBM.

- 4. For the proposed GBM, date will be finalized as per the availability of Chairman in the month of Dec 24 or Jan 25 and exact date will be announced later.
- 5. Dr G S Kapur, Vice chairman, proposed that in view of the increased numbers of life members and the vast jurisdiction of Delhi Chapter (almost whole of north India), and aspirations of members to contribute to the growth of Delhi Chapter, there is a need to expand the EC body in terms of numbers of EC members/positions & Co-option of EC members including nomination

of Executive Chairman for 2024-27. It was agreed by the EC and following were decided:

- Looking into long term association and contribution, Dr. J. Christopher to be part of the current EC (for the term 2024-27) as Executive Chairman.
- ii. From now onwards, Maximum 6 EC members can be co-opted, with preferably 2-3 members from outside of IOC R&D. However, EC can take the final call w.r.t to co-opted members, their numbers and organizations in order to have active & wider participation
- iii. Not more than one co-opted member from a single organization/Institute/University.
- iv. After detailed deliberation, the following members were co-opted as members of the executive Committee for the term 2024-27:
 - Prof M.S. Alam, Jamia Hamdard University, Delhi
 - Dr Ram Singh, Delhi Technological University
 - Dr Sravan Bompelli, IOCL, R&D Centre, Faridabad
 - Dr Hemant Tyagi, HMEL, Bathinda
 - *Dr A.S. Sarpal, Professor, FURG University, Brazil

(*As he is currently abroad, he will be co-opted once he is back in India)

- v. Mr. Trilok Singh, IOCL Finance Dept. to be retained as Advisor-Financial Matters.
- vi. Further, EC may invite any member/non-member as a special invitee in the meetings as per the needs and requirements on case-to-case basis. It was decided to invite following as special invitee in the next EC, so that they can present / apprise the initiative taken by them to further the growth of Delhi Chapter:
 - Dr Swami Maloth, IOCL, R&D Centre, Faridabad
 - Dr Veena Bansal, Adjunct Professor, JC Bose Institute, Faridabad
- vii. It was agreed to increase the numbers of Vice Chairmen and Joint Secretary from 2 to 3, in each case, from the next Elections, with the following conditions:
 - 1 Post reserved for ISAS-DC HQ, i.e. IOCL R&D Centre, Faridabad for members in service

- 1 Post reserved for members outside of IOCL R&D Centre, Faridabad
- 1 Post will be Open to all
- viii. It is also agreed to increase the numbers of Joint Treasurer to 2 from the next Elections, with the following conditions:
 - 1 Post reserved for ISAS-DC HQ, i.e. IOCL R&D Centre, Faridabad for members in service
 - 1 Post reserved for members outside of IOCL R&D Centre, Faridabad
- ix. There will be an age cap to 70-years to be eligible for a member to contest in elections for any position in the Executive Committee.
- x. The members interested in contesting the elections for any EC position must have their current address in the jurisdiction of the Delhi Chapter.
- xi. The constitution of the Chapter to be amended accordingly after ratification by GBM.
- xii. Election Nomination Form to be amended accordingly.
- xiii. It was also emphasized that all the elected/co-opted EC members should actively contribute by making new life members, arranging /organizing seminars/symposium or any relevant activity for the growth of the society.
- xiv. It was agreed that all the EC members should participate in the EC meetings and should not miss 3-consecutive EC meetings, in order to avoid invoking a constitutional clause of disqualification from the EC.
- xv. It was decided that the Vice Chairman & Secretary to be the nodal point for coordination with HQ on day-to-day basis.
- xvi. It was decided to increase the life membership fee from Rs 1500 to Rs 2000. Chairman also suggested that there should be some award for those making highest number of life members in a year.

6. Future Activities:

 Prof Devender Singh briefed the forthcoming event of 2 days international conference jointly with ISAS-DC on "Emerging Trends in Functional Materials in Sciences" at MDU Rohtak during 21-22, Nov 2024 with a budget estimate of Rs. 10 Lakhs. He mentioned that MDU has very good infrastructure facilities like an auditorium to conduct the conference and GH / hostel facilities for accommodation of delegates. ISAS-DC will support the event as per existing norms.

- Dr Ram Singh proposed organizing a conference jointly with SRM University, Sonipat in Feb 2025. EC will examine the proposal and decide.
- Prof AK Sharma, Vice Chairman will explore the possibility to organize Indian Analytical Congress (IAC-2025) at Srinagar. J&K preferably in the month of April-May, 2025.
- 7. It was decided that ISAS-DC website needs updating. In this regard, website Update Committee was formed as follows:

 - Dr Vishal Goel
 - Dr Sujit Mondal




